1. Nominee must be a present or past member of American Bowling Congress (ABC), Women International Congress (WIBC), Arizona Women Bowling Association (AWBA), Arizona Men Bowling Association (AMBA), Tucson Bowling Association (TBA), Tucson Women Bowling Association (TWBA), United States Bowling Congress (USBC), Tucson Metro USBC (TMUSBC) for 15 years, does not need to be consecutive years, unless injury, illness has shortened their career or military enlistment created break in years.
2. **Military Exception:** Must have been a member of the Men or Women Tucson Bowling Association or a recognized bowling organization at least one year prior to enlistment. Must have been associated with the organized bowling association (ABC, USBC, and local association) while enlisted no less than three years, must be able to produce proof (certification cards, letters from associations). Must have been a member of the Women or Men Tucson Bowling Association and, or Tucson Metro USBC upon discharge for no less than Five years before being considered.
3. Nominee must have demonstrated service before self, devotion and forward thinking with new innovations and convey new ideals, with their contributions and achievements they are above and beyond the ordinary, to the betterment of the sport of bowling and outside the framework of competitive bowling over 15 years.
4. Nominee must have distinguished themselves in the promotion and betterment of the Sport Of Bowling through meritorious service or outstanding leadership on the WIBC, ABC, USBC, TWBA, TBA, TMUSBC, board for 15 years.
5. A posthumous award may be awarded.
6. Nominee or Nominator must submit a complete questionnaire detailing all accomplishments by 15 December, 2011.
